TEACHING PHILOSOPHY AND STATEMENT:

Over the years I have taught in diverse settings. My philosophy is based on a few simple assumptions and understandings: 1) Everyone I encounter in my teaching sessions wants to learn; 2) both the learner and I benefit from honest feedback; and 3) it's often necessary to adapt the teaching style or format to the environment. The paragraphs below outline some of the settings in which I have taught over the years.

Grant writing training

For a number of years I taught a small group session in Epidemiology 805-806, a course that gives advanced postdoctoral fellows and junior faculty training and practice in writing NIH grants. Each student is expected to submit a draft grant application for mock review at the end of the year. The most successful students are those who use these sessions as a laboratory for crafting an actual grant for submission to the NIH. During the sessions each student receives specific feedback on their draft from the leader and the other students. Students provide each other with remarkably insightful feedback, but typically find it much more difficult to actually write an application themselves – in part because they have seen few if any examples of funded applications. In response, I provided my session members with applicable parts of my grants.

Continuing education for health professionals

Each year I give 4 weekly infectious disease lectures during the course of one month at Central Regional Hospital to a diverse audience that includes attending physicians (in internal medicine, psychiatry, and family medicine), physician extenders, psychiatry residents, pharmacists, and other health professionals. I have found that I best maintain their interest by soliciting their ideas for lecture topics and expanding the lecture format to include board-type questions that they answer as a group.

Clinical teaching and mentoring

Like most clinical faculty, I teach medical students, residents, and fellows on the Internal Medicine ward and Infectious Diseases consult service. Although the residency program prefers that attending physicians give didactic lectures on specific topics, the major

challenge in this exceptionally hectic environment is the combination of lack of time and critically ill patients. I counter this by using patients on the ward as a springboard for short discussions, since learners are more likely to retain information that relates to patients they have seen than information that is not tied to specific cases. In addition, I set aside short periods for individual sessions with medical students to address their questions and work on specific skills, such as case presentations. I review each student and resident's performance with them individually half-way through the rotation and at its conclusion.

My K24 award has enabled me to do a significant amount of mentoring – mainly of graduate students and postdoctoral fellows. I typically incorporate these trainees into my research, which provides them with practical experience. I also provide career mentoring.

Training for foreign researchers

I have been Principal Investigator and Director of the UNC Fogarty AIDS International Training Research Program (UNC AITRP) since its inception in 1998. As part of my role I have mentored trainees and conducted short-term in-country research training. This program has trained scores for researchers from Malawi, China, and Cameroon. Many have earned degrees in epidemiology and other disciplines and continue to contribute to HIV prevention research efforts after returning to their countries of origin.

Women's Interagency HIV Study (WIHS)

An unexpected benefit of my role as Principal Investigator of the UNC Women's Interagency HIV Study (UNC WIHS) is the extraordinary opportunities it gives for teaching and training that benefit not only the site, but also other investigators. From the start of the grant its premise has been that we would benefit from the exceptional resources and talent pool at UNC and one of the ways we would do this is to engage trainees and junior and senior investigators. Several months after we received our notice of award we began to have monthly working group meetings to familiarize investigators and students throughout the campus with the grant. These meetings are attended by a wide variety of researchers. including senior faculty, junior faculty, postdoctoral trainees, and graduate students. The meetings build in opportunities for discussion, networking, and collaboration. Our core leadership includes faculty and staff who assist investigators with selection of variables from WIHS' formidable existing data. We encourage investigators to submit concepts for all types of research: from grant applications for new data collection – to unfunded analysis of existing data. During the past few months alone, one doctoral student and two junior faculty members have submitted concepts that have been approved by the national WIHS leadership, and several additional concept submissions are planned by other investigators.

REFLECTIVE STATEMENT:

Much of my research could be characterized as social epidemiology with a focus on sexual behavior and the social and economic context of sexually-transmitted infections, including HIV. The ultimate goal of this work is to help end the AIDS epidemic –particularly it's disproportionate impact on minority populations. Some of my research is highlighted immediately below.

My work with Dr. Victor Schoenbach (UNC Epidemiology) has demonstrated the prevalence and correlates of sexual network patterns that facilitate population HIV transmission. Specifically, our population-based studies have noted a higher prevalence of concurrent sexual partnerships (sexual partnerships that overlap in time) among African-Americans than other Americans. This higher prevalence does not reflect racial differences toward partnerships, but appears instead to be largely a product of social and economic factors, such as group-level poverty and a low ratio of men to women (sex ratio), that discourage long-term monogamy. Recently, we empirically demonstrated the association between concurrency and other neighborhood-level poverty and the low sex ratio. These findings have substantial implications for prevention of HIV infection and other diseases.

My work includes community-based research with development of interventions to prevent HIV infection. A study conducted in collaboration with Centers for Disease Control investigators outlined risk factors for HIV infection among women in the South. I worked with investigators from the UNC's Schools of Public Health and Journalism to develop a mass media campaign whose goal is to disseminate results of our previous concurrency research and make attitudes of African Americans in eastern North Carolina less favorable to concurrency. We are currently evaluating the effects of the campaign. A community-based project conducted in collaboration with Shaw University, a local historically Black College/University (HBCU), showed that pastors of North Carolian Black churches are willing and able to participate in HIV prevention by developing and incorporating messages about sexual behavior into their sermons.

I recently extended my research to The Women's Interagency HIV Study (WIHS), an NIH funded multi-center study that has been operational since 1993. The WIHS is the largest cohort of women with and at risk for HIV infection in the US (and probably the world). But despite the importance of the epidemic in the South, the study had no representation in this region until 2012 when we successfully competed to become one of the new Southern sites. Through UNC WIHS I am fortunate to collaborate with investigators from many disciplines here at UNC and throughout the nation in epidemiologic, clinical, and translational research. This study represents an extraordinary opportunity to engage investigators – including young investigators – from a variety of disciplines here at UNC and facilitate their networking and collaboration with nationally known HIV researches.

I also serve as Chair of the HIV Prevention Trials Network's Women at Risk Committee. Our committee, composed of internationally known investigators, is charged with helping

to develop an agenda for research that results in prevention of HIV infection among women throughout the world.

These activities have provided a platform for many teaching opportunities, and my NIH K24 mentoring award and position as Principal Investigator and Director of UNC Fogarty AIDS International Training and Research Program (AITRP) have facilitated mentoring of graduate students, postdoctoral fellows, and junior faculty. Since its inception in 1998, UNC Fogarty AITRP has trained scores of researchers from Malawi, China, and Cameroon; most have returned to their countries to continue their contributions to HIV prevention research.

My future work will continue its focus on ending the disproportionate burden of the AIDS epidemic on minorities in the US with a particular emphasis on the southern United States. I plan to strengthen UNC WIHS and continue research through this and other collaborative research venues. I also hope to help guide the international AIDS research community toward prevention of HIV infection among women throughout the world. And finally, I plan to continue advocacy for HIV providers and our patients through my positions in the leadership of the HIV Medical Association and the Presidential Advisory Committee on HIV/AIDS.
