Founded in 1950 as a free-standing department of the UNC School of Public Health, the Department of Maternal and Child Health (MCH) is the only stand-alone, academically autonomous department of maternal and child health within an accredited school of public health in the nation. Our department is one of 13 Centers of Excellence in MCH Education, Science and Practice funded by the Health Resources & Services Administration, Maternal and Child Health Bureau. Our faculty, staff and students are dedicated to improving the health of women, children and families domestically and globally. Our teaching program provides students with broad exposure to maternal and child health population needs and priorities, as well as the skills to become leaders of tomorrow.



Given our population focus, we are committed to collaborative and interdisciplinary teaching, research and practice. MCH faculty members represent a rich mix of academic backgrounds and interests, contributing expertise in a wide range of topics that impact children and families. MCH faculty have received doctoral/professional training in pediatrics, nutrition, sociology, social work, epidemiology, statistics, psychology, economics, demography, geography, obstetrics and gynecology, maternal/fetal medicine, anthropology, and population/international health. The majority of our faculty members also hold graduate degrees in public health.

We offer an array of master's, doctoral, and dual degree options that encompass both domestic and global study, and include both research and practice. Our flexible curriculum allows students and their faculty mentors to craft learning opportunities that are uniquely suited to career goals. Our fully integrated, interdisciplinary population-based approach provides our students with broad exposures to MCH population issues, needs and responses in diverse settings and prepares graduates to be the MCH leaders of tomorrow.

Our research strengths include: developing a strong evidence base to improve health policies, programs and practices for women and children, locally and globally; working in interdisciplinary teams to develop innovative solutions for addressing health disparities among women and children; using innovative approaches, including implementation science, to support the successful implementation of proven women's and children's interventions at scale; and using quantitative and qualitative methods to improve the health of women, children and families in North Carolina, the nation and the world.

The demand for well-trained maternal and child health professionals continues to expand, both within the United States and globally. Most of the eight United Nations' Millennium Development Goals¹ were
