

The UNC School of Public Health has included continuing professional education as part of its mission since its founding over 50 years ago. The Office of Continuing Education is the largest continuing education department of any school of public health.

The Office of Continuing Education (OCE) designs and delivers nondegree professional education and training programs focused on improving the performance of public health professionals, many of whom require continuing education for licensing and certification.

Last year over 13,000 public health professionals received continuing education trainina in 283 courses offered by the Institute.

Many programs, workshops, and conferences are developed by practitioner-based committees who engage with the Institute for program planning activities, curriculum and content development, and program evaluation.

Work has begun on the North Carolina Public Health Academy, a three-year project funded by the Duke Endowment. OCE will work with Area Health Education Centers (AHECs) to provide conveniently accessible professional training opportunities customized to local public health educational needs, in essence, taking the University to the field.

The HRSA-funded Southeast Public Health Training Center (SPHTC) works very closely with OCE to develop, deliver and disseminate competency-based public health training in North Carolina and other southeastern states. The SPHTC focuses specifically on public health nursing and rural public health workforce development. The SPHTC maintains a large database, Askphere.org, of public health trainings and resources for trainers that can be used in competency-based training development.

Similarly, the North Carolina Occupational Safety and Health Education and Research Center (OSHERC) provided over 100 courses last year for specialists who ensure workplace safety and health. NC OSHERC provides education targeted for eight southeastern states but includes participants from all states and foreign countries as well.

"Global threats, accreditation requirements, and an aging workforce are but a few of the ongoing challenges for workforce development. Practitioner training that is on target, timely and delivered close to the workplace is critical to support the health of all North Carolinians."

The Certificate in Core Public Health Concepts program is one of the first of its kind, enabling working public health professionals to earn online credit toward a public health

New executive education programs were established last year including an epidemiology certificate, customized programs for Novant and the American College of Obstetricians and Gynecologists, and **Emerging Leaders in Public** Health to serve minority public health leaders.

This year the Institute's flagship leadership and management programs—

the National Public Health Leadership Institute, Southeast Public Health Leadership Institute and Management Academy for Public Health—

have graduated over 1300 public health managers and leaders combined. These programs bring together distinguished faculty from the UNC School of Public Health and partners such as the Kenan-Flagler Business School and the Center for Creative Leadership to help public health practitioners serve their communities and organizations more effectively.

The Emerging Leaders in Public Health program, in partnership with the Kenan-Flagler Business School and with help from the W.K. Kellogg Foundation, celebrated its second year. Under the topic "Managing in Turbulent Times," the program has thus far helped develop 86 individuals working with underserved Latino, African-American and Native American communities to take on expanded leadership roles in the next decade.

Our enrollment success—340 professionals are in the on-line program today—has led to the introduction this year of a second on-line certificate program, in Field Epidemiology (120 are currently enrolled). Two additional programs are being proposed, including an on-line Global Health certificate.

This year the Office of Executive Education has increasingly used its extensive experience at curriculum design and track record of organizational impact to develop custom programs for specific groups.

In the past year, the NCIPH Office of Consulting and Technical Assistance directed over thirty projects, including several community public health assessments. One such assessment was undertaken for Wilkes County in partnership with the Wilkes Community Health Council (WCHC) and the Healthy Carolinians affiliate in Wilkes County. WCHC spearheaded a community effort among public health officials, agency leaders and concerned citizens to streamline, improve and enhance the delivery of services to senior citizens throughout Wilkes County. Institute staff, with assistance from UNC School of Public Health graduate students, supported the project, identifying the county's providers of senior services, conducting telephone interviews to assess service needs, and investigating best practices in infrastructure for effective delivery of senior services. Based on this research, NCIPH made recommendations to the coalition to improve planning and delivery of senior services in Wilkes County.

The Institute has played a central role in the legislatively-supported public health incubator collaboratives program. It has consulted extensively with the six incubator partnerships comprising 79 participating counties.

The Institute has assisted North Carolina's innovative public health incubator collaboratives in securing over \$3,000,000 in grants and contracts to address local public health priorities. These Partnerships have combined resources to address common health priorities. This year a diabetes media blitz, a campaign to reduce teen smoking, and a mobile HIV-counseling van were just a few of the over twenty innovative projects "hatched" by the incubators.

Evaluating programs, plans, and results is an important component in aiding organizational development. The Institute's evaluation team is proud of its work with the Institute's primary partners, the North Caroling Division of Public Health and the North Caroling Association of Local Health Directors, on the pilots of the North

Carolina Local Health Department Accreditation program. Evaluations among the pilot health departments undergoing accreditation were critical to the success of the process and helped garner support for the program.

Institute evaluators have also been part of the nationally-recognized studies focused on preparedness capacity and response to hurricanes, with applications for other public health emergencies. This year they completed work with the Mississippi Department of Health, responders to Hurricane Katrina.

Service in Organizational Development

The Institute has also served as the administrator for the state's local health department accreditation program. With the Division of Public Health, the Institute has provided assistance to twenty local health departments which have become accredited. This work has been recognized by the Robert Wood Johnson Foundation. North Carolina has been chosen as one of five states to participate in a nationwide accreditation learning collaborative.

The focus of local health department accreditation is on the capacity of the local health department to perform at a prescribed, basic level of quality the three core functions of assessment, assurance, and policy development and the ten essential services as detailed by the National Public Health Performance Standards Program. The program focuses on a set of minimal standards that must be met to ensure the protection of the health of the public.

Serving as Accreditation administrator, NCIPH coordinated 10 site visits to local health departments around the state this past year as part of this process.

North Caroling was chosen as one of five states to participate in a nationwide accreditation learning collaborative, supported by the Robert Wood Johnson Foundation and in partnership with the NC Division of Public Health. The Nation's Health, the main publication for public health professionals, in its March issue, recognized the Institute's role as administrator of the accreditation process for local health departments.

Service addressing Preparedness

The North Carolina Center for Public Health Preparedness (NCCPHP) is a member of a national network of 27 Centers for Public Health Preparedness funded by the U.S. Centers for Disease Control and Prevention (CDC) to improve the capacity of the public health workforce to prepare for and respond to terrorism and other emerging public health threats.

In 2006, the Center was awarded funding from the CDC International Emeraina Infections Program to develop curriculum for avian influenza rapid response teams in Southeast Asia. More than 130 participants from 14 countries received hands-on training.

NCCPHP provides a wide array of training and technical assistance in public health preparedness and applied epidemiology. The Center manages major projects, including the Training Web Site (a database of training modules) that has over 12,400 users from 146 countries, the North Carolina Workford Development System (a learning managemen system related to assessment and training for North Carolina public health professionals), the publication of Focus on Field Epidemiology, and the Field Epidemiology Certificate program.

In 2006, the Center also managed contract projects with the NC Division of Public Health,

the West Virginia Department of Health and Human Services, the CDC, the National Association of County and City Health Officials (NACCHO), and the Council of State and Territorial Epidemiologists (CSTE), as well as grants from the Association of Schools of Public Health (ASPH) and the Robert Wood Johnson Foundation.

Also in 2006, NCCPHP expanded its work around avian and pandemic influenza preparedness. NCCPHP began working in partnership with the North Carolina Division of Public Health to provide local health departments with technical assistance around pandemic influenza response plan development.

Service addressing Active Living

Active Living by Design (ALbD) was launched in late 2001 as a national program of the Robert Wood Johnson Foundation (RWJF). ALbD helps partnerships across the nation increase routine physical activity and healthy eating through changes in community design

Midway through this initiative, ALbD's 25 diverse community partnerships have made excellent progress. To date, the ALbD community partnerships have implemented myriad

> • Amended development ordinances and established new street design standards • Created parks, trails, greenways, and community gardens • Implemented social marketing campaigns to increase awareness of opportunities for physical activity and healthy eating • Changed school policies regarding recess and lunch menus • Launched new programs promoting safe routes to school, bicycle recycling and distribution, and prescriptions for physical activity.

> > In the past year, ALbD began working with several other organizations to test and replicate its comprehensive approach to community change. One example of this effort is in Minnesota, funded by Blue Cross and Blue Shield, where ALbD is working with a number of counties and municipalities to build local involvement and support for active living into communities. ALbD also provides technical assistance to two active living initiatives in North Carolina.




Nursing Educational Task Force meeting at the Institute





National Outreach at the NC Institute for Public Health




Activities outside the U.S. by the NC Institute for Public Health


