DEBRA BINGHAM

Project Director

California Maternal Quality Care Collaborative Stanford University Medical School Residence: California

Debra Bingham, MS, RN, LCCE, has worked in the field of Maternal Child Health Nursing for more than 29 years. Her education and career began in Idaho and Utah where she held staff and leadership positions at community and tertiary-level hospitals. In 1983, she moved to New York City and held progressive leadership positions at the Children's Hospital of New York (CHONY) at New York Presbyterian Medical Center (NYPMC). While at CHONY she formed and directed the Neonatal Parents' Support Network. In 1990, she was honored by her colleagues as "Nurse of Distinction" for NYPMC and in 1991 as "Nurse of Distinction" for New York State, Region I.

From 1995-2006 Debra worked at St.Luke's-Roosevelt Hospitals in New York City and was promoted to the position of director of Maternal Child Health (MCH) nursing for St, Luke's and Roosevelt hospitals. As the Director of MCH Nursing, Debra had full fiscal responsibility and clinical oversight of the 24-hour, 7-day-a-week work of over 250 nurses in two hospitals in 7 specialty units. In collaboration with her leadership team Debra successfully improved clinical care in all the units she was responsible for through

the systematic implementation of quality improvement projects. Some of the major changes made were: 1) keeping mothers and newborns together, 2) pain management assessment and treatment for newborns and pediatric patients, 3) the coordination and development of an out-patient perinatal and pediatric bereavement support service to complement the in-patient services, and 4) integration of in-patient, Emergency Department, and out-patient pediatric asthma care.

Debra moved to California in 2006 and is currently the Project Director of the California Maternal Quality Improvement Collaborative (CMQCC). CMQCC is a newly forming private and public quality improvement multi-organization collaborative funded by the Maternal Child Adolescent Health Program of the California State Department of Health through Stanford University School of Medicine. CMQCC's charge is to improve maternity care in the entire state of California where there are approximately 550,000 births a year in 350 hospitals. One out of eight births in the United States occurs in California. CMQCC is the sister organization of the California Perinatal Quality Care Collaborative (CPQCC) which is focused on high-risk neonates in Neonatal Intensive Care Units and was established 10 years ago.

Other organizational activities include Debra's role as a member of the Board of Directors of Lamaze International and the Chair of the Lamaze International Institute for Normal Birth. Debra also serves on the California Maternal Infant Health Assessment (MIHA) Advisory Committee.

Debra is working on a Doctorate in Public Health at the University of North Carolina and her doctoral dissertation focus is the analysis of quality improvement behaviors of medical and nursing front-line leaders and the development of an implementation plan to improve one quality improvement behavior of the front-line leaders analyzed.

Priscilla Flynn, RDH, MPH, CHES is currently the Coordinator of the Office of Women's Health at Mayo Clinic in Rochester, Minnesota. She maintains licensure as a registered dental hygienist and is certified as a health education specialist and program evaluator. Her dissertation topic is "The Effects of Acculturation on Somali Women's Birth Outcomes". Current areas of focus include conducting multidisciplinary quality improvement initiatives, developing health education programs for Somali refugee women and implementing institutional cultural competency policies. She speaks nationally on women's refugee health topics and program evaluation practice.
