TEACHING AND INSTRUCTION

Systems Approaches to Understanding Public Health Issues (SPHG713), Online and Residential Course Co-Developer, 2017-2018, Online Co-Lead, 2018-2023. Residential Co-Lead and Instructor, 2018-current.

Description: This course explores: 1) what constitutes a public health issue and why; 2) systems approaches to understanding factors that determine population health patterns and inequities; and 3) strategies for communicating with diverse audiences about public health issues. This course is part of a 12-credit, 2-semester integrated core public health training program completed by all MPH and terminal MSPH students in the Gillings School of Global Public Health.

Enrollment & Format: Enrollment of 150-300 students per semester (residential), 50-100 students (online).

Theoretical and Conceptual Foundations of Health Behavior (HBEH 815/816), *Instructor*, Population Health (Fall) and Social Determinants of Health (Spring) Modules, 2011–2020; Complete 816 course: Spring 2021-current.

Description: Seminar course required for first year doctoral students in the Health Behavior department. The seven-week population health module provides an overview of concepts, frameworks and normative underpinnings of population health and behavior. The six-week social determinants of health module is designed to facilitate student understanding of the ways in which social structures might impact opportunities, lived experiences and choices related to health.

Enrollment & Format: 9-14 students per semester; Residential.

Social and Behavioral Sciences in Public Health (HBEH 600), *Instructor*, Fall, Spring & Summer as offered, 2004–2020, *Co-Instructor*, Spring, 2000–2003, *Teaching Assistant*, Spring, 1999.

Description: Survey course required for most public health undergraduate and master's students specializing in fields other than health behavior to introduce them to health behavior theory, health promotion program planning and implementation, and program evaluation.

Description: This course accompanied an individual student's service learning internship with the American Red Cross. Coursework was designed to provide academic foundations of relevance not only to the student's specific internship experience, but also to the broader field of health education.

Enrollment & Format: 1 student, Independent study.

Introduction to Public Health (HBHE 700) *Co-Instructor*, Fall 2008.

Description: Lecture course designed to provide first year master's students with an orientation to the fields of public health and health behavior and health education.

Enrollment & Format: 45 students; Residential.

Social Determinants of Health (HBHE 802/EPID 825) *Instructor*, Fall 2004–2007.

Description: Elective course designed to familiarize health behaviour and epidemiology graduate students with sociological theory in the context of public health, and provide and in-depth exploration of social determinants prevalent in public health literature, and the theoretical and practical application of social theory to public health research and intervention.

Enrollment & Format: 13-16 students per semester; Residential.
