Research Statement

I am a primary care physician, health services researcher, and Assistant Professor at the University of North Carolina (UNC) at Chapel Hill. The Division of General Medicine and Clinical Epidemiology at UNC has been my professional home since 2012, following residency and fellowship training at Duke. I was attracted to the Division and the opportunity to deepen my research skills and collaborate with faculty in working in medicine and public health, in both *education and research*.

As a practicing primary care physician, researcher, and public health educator, my background and skills are uniquely suited to developing the evidence base on which we rely to care for patients, train students, residents, and fellows, and contribute to the concatenation of research translated into practice. My clinical, teaching and research focus on prevention science. I am board certified in general internal medicine and have additional training in preventive medicine/occupational medicine. My eighteen years of clinical practice experience include diverse primary care and occupational medicine settings. My primary research interests and areas of expertise are in topics relevant to prevention science, mental health, women's health, and evidence-synthesis methods (critical appraisal, systematic reviews, and meta-analysis). As Associate Director and, at present, Acting Director of the RTI-UNC Evidence-based Practice Center (EPC), I have substantial experience conducting systematic reviews including various topics for the US Preventive Services Task Force (USPSTF), the Agency for Healthcare Research and Quality's (AHRQ's) Effective Health Care Program, and other stakeholders.

I have served as principal investigator for multiple systematic reviews, meta-analyses, primarily via the Agency for Healthcare Research and Quality (AHRQ). My publications in JAMA, the Annals of Internal Medicine, and elsewhere gives me the opportunity to synthesize peer-reviewed research with educational significance while they also contribute directly to high value clinical practice. My EPC work has developed my methodological expertise in evidence

synthesis methods to inform decision-making. In addition to evidence-synthesis, I have experience with a variety of types of research and with mentoring researchers at many levels, including medical students, public health students, residents and fellows, faculty, and research staff (see my Teaching Statement, below).

The Cecil G. Sheps Center for Health Services Research at UNC Chapel Hill has been a research home for me since 2012. Since that time, I have moved from being a researcher to the Associate Director of the RTI-UNC Evidence-based Practice These leadership roles involve a significant commitment to promoting collaboration both within UNC and with external organizations.

At present, I am the Director of the UNC EPC team, where I lead a core group of 3 staff along with dozens of investigators from across UNC to collaborate with RTI International as we produce rigorous evidence reviews for the USPSTF, the Centers for Medicare and Medicaid Services (CMS), and other stakeholders. Our work has been published in top tier journals, as can be seen in my list of refereed publications above and is often presented nationally to groups developing clinical practice guidelines. These publications further the establishment of our position as nationally and internationally recognized methodological experts in evidence-based practice. Our EPC is a US affiliate of the Cochrane Collaborative, extending our research engagement to the international arena of systematic review methods.

Our EPC has grown over the last decade, supported by awards from AHRQ and contracts from the Drug Effectiveness Review Project (DERP). As the UNC EPC Director, my vision for the center is to continue our excellent track record (of over 20 years) of doing reliable, high-quality work that is published in top tier journals, and to continue to grow our methodological expertise as national and international leaders in evidence-based practice for the betterment of health care education and clinical practice.

Teaching Statement

My leadership in population health education at UNC's School of Medicine and the Gillings School of Global Public Health (SPH) complement my research in evidence-synthesis and prevention. As director since 2018 and "co-Lead" of UNC's longstanding MD-MPH program, now known as the Population Health for Clinicians MPH concentration, I lead or participate in the curriculum development of multiple courses focused on prevention science, evidence-based practice, critical appraisal, systematic reviews, and cost-effectiveness. One of the educational accomplishments of which I am particularly proud is my creation of a course on costeffectiveness, which began as a one-credit course in the spring of 2012. Based on positive feedback from students and faculty, I went on to expand the course, making it a 2-credit elective for the MD-MPH students and some Master of Science in Clinical Research students, along with students from other departments in the Gillings School and other Health Affairs schools. I continue to lead most sessions, which include a lecture on methods or policy related to economic evaluations of health care interventions and their use in clinical and policy decision-making. Sessions also include small group discussions focused on the critical appraisal of costeffectiveness analyses. I have recruited colleagues from the UNC Department of Medicine to give guest lectures and recruited outside faculty from Duke and Blue Cross Blue Shield to speak

on various topics related to health economics. In addition to leading the cost-effectiveness course, I am also lead-instructor for the Strategies of Prevention and Systematic Review Courses, both hallmark concentration courses of our MD-MPH degree program.

The PHC concentration builds on a program designed for medicals students, residents and physicians to increase the workforce prepared to address health issues at the intersection of medicine and public health. PHC is the only accelerated MPH concentration and is supported, in part, by funds from the SOM Dean's office. The concentration also attracts medical students and residents from other institutions. In my tenure as concentration Lead, I have participated in a school-wide effort at Gillings to revise the MPH degree curriculum. The former Health Care and Prevention MD-MPH program transitioned into the a "Population Health for Clinicians (PHC) Concentration", which is one of eleven new MPH concentrations at Gillings. Since this transition, I have served on the MPH Steering Committee at Gillings and led efforts to improve the PHC curriculum. In Fall 2024, we are implementing a revised version of the curriculum that includes numerous innovative strategies to ensure students continue to receive a high-quality, rigorous, and relevant education that compliments their clinical training. Teaching, mentoring, and advising in the program, as well as having a prime responsibility for administering it, now command more than half my effort.

In addition to my substantial role in the Population Health for Clinicians MD-MPH program, I have taught in many settings. In the clinical arena, I have served as a clinic preceptor in the Residents' Clinic from 2012 through 2023. In the past, I precepted residents about 1 session per week. I have also precepted medical students in my own outpatient internal medicine clinic. In addition, I am frequently invited as a guest lecturer for courses and seminars on topics related to systematic reviews, meta-analysis, comparative effectiveness, prevention, and screening. I have also served as core faculty member in the UNC Preventive Medicine and participated in developing a successful proposal for the HRSA training grant used to recruit and support residents. As a researcher in prevention and from my national work related to guidelines and recommendations, I strive to bring current preventive perspectives to clinical teaching. I serve as an advisor and/or mentor to students and fellows working on numerous projects (see mentoring table above), and actively recruit students, residents, and fellows from various UNC programs to participate in research experiences.

Course evaluations have consistently rated me very highly and have reflected my ability to present course materials effectively, provide useful feedback, demonstrate competence in course subjects, and create a positive learning environment.

In 2020, I became the new Director of the Holderness Distinguished Scholars Program. In 1980, the Howard Holderness family established the Holderness Medical Fellowship Program to help improve the health of the citizens of North Carolina and the nation through research and scholarship. In 2006, the Holderness Fellowship Program became the Holderness Distinguished Medical Scholars Program, a two-year program of independent research and seminars to encourage independent inquiry into the science and philosophy of medicine. The Holderness Programs have stimulated and encouraged student-faculty relationships and scholarly inquiry by providing financial support for more than 375 students in the last 40 years. I look forward to growing this program and finding synergy across other educational programs to propose student

involvement in research and scholarship.

As I hope is evident in these pages, all my teaching, at every level, seeks to synthesize the rigorous development and patient-centered application of the best evidence, to prepare trainees for a career of providing the best informed and highest value care.
