

#### **Committee: Consumers**

**Problem:** We are not reaching mothers, support people or healthcare providers in a smart, savvy, marketable way. Formula companies are.

**Objective(s)**: By 2015, create a communication strategy that increases consumer demand for Ten Steps' implementation.

Activities: 1. Research existing state/ national resources to share with consumers. 2. Utilize Interstate Collaborative portal for sharing (social media, Listserv). 3. Identify key stakeholders for implementation of communication strategy (State Health Departments, State Coalitions). 4. Monthly release of information- through portal. 5. Create the criteria for testing for suitability of information (vetting process). 6. Consider use of Power of Influence principles in strategic plan

**Problem:** Mothers are not effectively linked to support in the first critical weeks.

**Objective:** A. Develop an algorithm with examples for support in line with the SGCTA sectors for a community breastfeeding support path, draft by July, 2014 and final by December, 2014.

**Activities:** 1. Survey Collaborative members to send 1-2 best practice(s) in their area. 2. Review and select. 3. Organize into draft. Partner with USBC Continuity of Care program.

**Problem:** We are not prepared to communicate effectively with HC leaders.

**Objective:** A. Within one year, develop a plan for local coalitions to use data from moms in the community on the patient experience of care; post on the Collaborative's externally-facing website. B. Within one year, develop Question and Answer Conversation Aide for Helper Groups / BFHI advocates to use when discussing implementing the Ten Steps and/or BFUSA designation with hospital leaders; post on Collaborative's externally-facing website; Disseminate through Collaborative member organizations.

**Activities:** A1. Analyze data from PRAMS, Childbirth Connection and other by December, 2013. A2.Develop messages and share with Collaborative via webinar by March, 2014. A3. Share via USBC-CDC Teleconference April 8, 2014. A4. Engage all state coalitions through USBC by August, 2014. B1. Synthesize list of common leadership concerns by Feb, 2014. B2. Develop and refine responses by March, 2014. B3. Format and disseminate publication.

#### **Committee: Infant Formula Marketing**

**Problem:** Free formula marketing distribution in hospitals

**Objective:** A. Develop a set of materials to present risk management argument for NOT distributing formula and formula marketing at hospitals, for exhibition at National Conference of Healthcare Risk Management Professionals in October, 2014. (B. Launch a consumer-oriented campaign to "Leave the Bag Behind." To be considered after first objective is complete.)

**Activities:** A1. Search for what is already developed through Ban the Bags, NABA, RI, No Free Lunch, etc.: Kathy and Martha. A2. Review and discuss how to synthesize, partner and what is missing. A3. Find a lawyer to assist with legal approach (Sylvia). A4. Create content, and vet with collaborative. A5. Put content into graphic design, etc. (Jeanine, Catherine, Martha, Tina). A6. Share at National Mtg. A7. Compile list of contacts, and send follow-up emails to share with colleagues and hospitals.

#### **Committee: Legislation and Policy**

**Problem:** Lacking federal regulation that supports the use of breastfeeding and breast milk for infants.

**Objectives:** Partner with 10 state breastfeeding coalitions or breastfeeding coordinators to establish joint acts with their states' Perinatal Quality collaborative to support the Childbirth Connection on the HR 896 bill.

**Activities:** Produce a one page document, composed to help states achieve this collaboration. Marion will gather information on how Oregon has achieved their collaboration; locate where to get information on the bill, and ideas for collaboration. Meghan will contact Childbirth connection as well as National partnership for women and families to determine their needs at this time. Meghan will also explore USBC's role in this bill. Timeline: 2-4 weeks. Jessica and Claire will be responsible for gathering the individual pieces and disseminating it throughout the group.

#### **Committee: Physicians**

**Problem:** Not enough physicians are trained in supporting BF.

**Objectives:** A. Develop a resource listing with links of 3 hour courses for practitioners and related materials. B. Request extension of educational requirements (by BFUSA). C. Develop a more Ten Steps'-oriented 3-Hour Course with adjunct algorithms and apps.

**Activities:** A1. Kay Hoover will send out a request for resources with a few sentences description after she receives the list of group members from Miriam by June 15. List will be posted as soon as possible for others to review and add. Then it will remain posted on group portal. B1. Develop a proposal within three months (by Aug 1 by Helen and Denise) to be vetted by group, asking BFUSA to extend provider 3 hour training requirement to anyone with OB or newborn hospital privileges. C1. Develop a workplan for a draft of the course content. Susan, Joan, DeeAnne and Miriam will review existing 3 hour courses after listing developed, and develop a workplan by Dec 1 for draft development to be finalized in the next 6 months, then share for working group approval to proceed with plan. C. Adjunct Approach: November, MA will launch information will be shared in discussion with RI (Kristen Brown), then vet with working group in November for consideration for building upon it.

#### **Committee: Return on Investment / Cost-Effectiveness**

**Activities:** A1. Roger to send group RAND document on how to create a research agenda. A2. Turn meeting notes into list of research questions (and variables of interest), and refine/prioritize in committee, then vet with Collaborative, then vet with pilot of healthcare administrators (NICHQ? Partnership). B1. Create a list of target funders (USDA Research Group), and disseminate to them; follow-up.
