#### **OVERVIEW**

I am an Associate Professor in the Department of Health Policy and Management at the University of North Carolina at Chapel Hill (UNC). I also co-direct the Implementation Science Methods Unit at the NC Translational and Clinical Sciences Institute (TraCS), UNC's CTSA, that supports use of implementation science frameworks and methods in research conducted at UNC. I teach two graduate courses (one per year) in the UNC Gillings School of Global Public Health: 1) Implementation science in health (course code: HPM 767); and 2) Patient-reported outcome measures (PROs) and application in care delivery and research (course code: HPM 794).

My research program identifies important gaps in implementing evidence-based practices (e.g., PROs) in clinics and how those gaps are related to poor patient and clinic outcomes, such as low treatment satisfaction and acute care use. My research program (as MPI) on implementing PROs in cancer care delivery is funded by Pfizer Global, Sivan Innovation, the Hematology/Oncology Pharmacy Association, and the Cancer and Aging Research Group. My grant from Pfizer is testing implementation outcomes for a novel care model where oncology pharmacists serve as PROM monitors instead of nurses; we are one of ten health systems funded as a U.S. collaborative to roll out PROMs. I serve on the steering committee for PROTEUS-Practice (PROTEUS = PROM Tools: Engaging Users & Stakeholders), which is the premier international initiative advancing implementing PROs in usual care. I was also part of the writing group for the European Society of Medical Oncology (ESMO) clinical practice guidelines for using PROs in practice (Di Maio et al. Annals Oncol. 2022;33:878-892). I serve as a co-investigator on grants funded by NINR (PI: Rocque at UAB), NCATS (PI: Buse), NHLBI (PI: Stevens), AHRQ (PI: Elston Lafata), and the American Society for Clinical Oncology (PI: Miller Ray).

My work uses mixed methods to study health care systems, including electronic health record data extraction, stakeholder interviews with patients and clinicians, implementation science, and psychometrics. For example, I conducted foundational work developing implementation science metrics to evaluate initiatives implementing patient-reported outcome measures (PROs) in routine care settings (Stover et al., QOLR 2021). My work showcases my ability to recruit stakeholders (patients, providers, and health systems) for research participation, and working with health systems and stakeholders to co-develop, implement, and evaluate evidence-based practices.

## **BIBLIOGRAPHY**

## (As of May 17, 2024: 64 publications, Google Scholar: 6,653 citations)

My research has had significant impact in the field. I have published 64 peer-reviewed publications that have been cited more than 6,000 times. In 2019, Expertscape added me to their world-ranked expert list for quality of life research; they also added me in 2021 for patient outcome assessment. Expertscape ranks a world expert as being in the top 1% in research and publications for that topic worldwide. Google scholar also quantifies other benchmarks for researchers, including the i10-index and h-index. The i10-index shows the number of publications with at least 10 citations. My i10-index of 47 means that 47/64 of my publications (73%) have been cited at least 10 times. The h-index is a metric for evaluating the cumulative impact of an author's scholarly output by comparing the number of publications to citations. The h-index corrects for the disproportionate weight of highly cited publications or works not yet cited. According to Hirsch, an h-index of 20 after 20 years of scientific activity characterizes a successful scientist, 40 is outstanding, and 60 represents truly unique scientists. My h-index of 32 is exceptional for my career stage.
