Leila C. Kahwati is a primary care physician, senior research scientist, and Fellow in RTI's Translational Health Sciences Division. She brings more than 20 years of experience in government, community, and academic health care practice and research settings with a focus on evidence synthesis to inform clinical program and policy development and evaluation. She is currently Associate Director of the RTI-University of North Carolina Evidence-based Practice Center. Dr. Kahwati is board certified in family medicine and in general preventive medicine/public health and has additional training in epidemiology and health services research. She has conducted systematic reviews and mixed-methods studies, and she has experience with qualitative comparative analysis. Before joining RTI, Dr. Kahwati served as the Deputy Chief Consultant for Preventive Medicine in the Veterans Health Administration (VHA), where she led efforts to implement comprehensive health promotion and disease prevention services throughout the VHA. Since joining RTI, she has served in various roles including project and associate project director, task lead, and senior scientific advisor on several research and evaluation projects for clients including the Centers for Medicare & Medicaid Services (CMS), Agency for Healthcare Research and Quality (AHRQ), the Food and Drug Administration (FDA), the State of Washington Health Care Authority, and the VHA.

Systematic Reviews of Topics Related to Medical Product Promotion and Clinical Trials (2015 to 2016)—Principal Investigator for Topic 2. As a contractor to FDA, RTI conducted rapid systematic reviews for three topics. Served as the principal investigator of topic 2 with an objective to synthesize the literature related to prescriber training and education in clinical trial design, evaluation, and analysis. This included topic and search strategy development, screening of titles, abstracts, and full text articles for review eligibility, oversight of data abstraction, and drafting of final review report and evidence tables.

Meta-Evaluation of Centers for Medicare and Medicaid Innovation (CMMI) Primary Care Initiatives (2014 to 2017)—Senior Scientific Advisor. Working as a subcontractor to Kennell and Associates, RTI conducted a meta-evaluation of six CMMI-funded demonstrations related to primary care practice transformation to identify new findings and insights through comparisons, contrasts, and synthesis of

demonstration experiences and outcomes. Advised project team on approach relating to coding demonstration features for use in quantitative and qualitative analysis and determining appropriate unit of analysis and feasibility of practice-level analyses.

Deimplementation of Inappropriately Tight Glycemic Control (2014 to 2017)—Consultant. The overall aim of the study was to generate new knowledge about large-scale health care practice transformation by studying the impact of the Choosing WiselyTM campaign that will be tailored for use in the U.S. Department of Veterans Affairs (VA). Specifically, this campaign tailored for use in the VA sought to reduce overintensive glycemic control among patients with diabetes.

Implementing a Depression Screening and Treatment Toolkit in Primary Care: Innovations from the Field (2014 to 2015)—Principal Investigator. This study was in partnership with UNC and Community Care of North Carolina and is funded through the North Carolina Translational and Clinical Sciences Institute. We conducted a formative evaluation among a sample of adult primary care clinics in central North Carolina regarding readiness to implement a depression screening and treatment toolkit. Focus groups and surveys were used to develop a menu of implementation options that were evaluated for acceptability and feasibility in a second round of stakeholder focus groups.

Health Care Innovation Awards: Meta-Analysis and Evaluator's Collaborative (2013 to 2018)—Co-Task Lead and Clinical Advisor. CMS provided more than \$1 billion in funding to health care organizations nationwide to test new payment and delivery models designed to enhance the quality of care, lower health care costs, and improve patient outcomes for Medicare, Medicaid, and Children's Health Insurance Program enrollees. CMS funded RTI to synthesize the experiences and results of the entire portfolio of 108 awardees and convene an evaluator's collaborative to support cross-evaluation efforts. Co-led qualitative analysis task, which is based on the Consolidated Framework for Implementation Research and included several qualitative comparative analyses.

Evaluation of the Multi-Payer Advanced Primary Care Practice Demonstration (2013 to 2017)—State and Qualitative Data Collection and Analysis Team Member. This 5-year project evaluated patient-centered medical home demonstrations implemented in eight states: Maine, Michigan, Minnesota, New York, North Carolina, Pennsylvania, Rhode Island, and Vermont. Individual-, practice-, and system-level data was collected and analyzed for state initiative implementation, practice transformation, and outcomes (clinical quality of care and patient safety, access to and coordination of care, special populations, beneficiary experience with care, patterns of utilization, Medicare and Medicaid expenditures, and budget neutrality). Served as a member of the North Carolina state evaluation team and led the qualitative comparative analysis task.

Safety Program for Perinatal Care (2013 to 2016)—Associate Project Director/Medical Director. RTI partnered with several health care systems through this AHRQ-funded project under the Accelerating Change and Transformation in Organizations and Networks master task order. This project developed a toolkit and training program to improve consistent use of safe practices in labor and delivery (L&D) units. The intervention design was based on the AHRQ Comprehensive Unit-based Safety Program and was tailored specifically to L&D units. It included webinar trainings, continuing education accreditation, and technical assistance for more than 50 implementing L&D units. Provided senior oversight related to all clinical program materials and the evaluation.

Feasibility of Qualitative Comparative Analysis (QCA) within Systematic Reviews of Complex Interventions (2013 to 2015)—Principal Investigator. This AHRQ-funded Small Research Grant examined the feasibility of using QCA in a systematic review of a complex health intervention to enrich review results by identifying key intervention features associated with effectiveness.

State Innovation Models (2013 to 2014)—*Co-Task Lead*. The goal of this CMS-funded project was to independently evaluate this initiative to test whether new payment and service delivery models will produce superior results when implemented in a state-sponsored comprehensive State Health Care

Innovation plan. Co-led the task of evaluation of the 16 Model Design Award States and three Model Pre-Testing Award States and led the Maryland State Team. This task involved evaluation of the process that these states used to create their Health Care Innovation plan. The evaluation included use of stakeholder interviews, document review, and review of secondary data to create state case studies and a report synthesizing cross-state lessons learned.

Measuring the Effectiveness of the PTNow Clinician Portal for Behavioral Change (2012 to 2013)— Task Leader. This project developed an evaluation plan for measuring the effectiveness of a clinician portal designed by the American Physical Therapy Association to disseminate evidence-based clinical summaries for physical therapists. Led the task associated with identifying and recommending validated instruments and measures for the evaluation plan, and provided content expertise to the evaluation team regarding dissemination and implementation science.

Development of an Online Health Risk Assessment for the VHA (2010 to 2012)—Project Director (Business Side). Served as the non-IT government project officer for the development and implementation of a VHA-specific electronic health risk assessment, which included an assessment of cardiovascular risks and provision of tailored guidance and recommendation to patient and his/her provider. As part of this effort, she chaired the internal VHA Project Steering Committee and the project's internal Clinical Advisory Board. Responsible for modifying commercial off-the-shelf product clinical content to be suitable for VHA setting and population, clinically validating the application, and vetting/managing all clinical content change requests.

Patient Experiences with MOVETM! Weight Management Program for Veterans (2010 to 2012)—Principal Investigator. The aims of this project, funded by the VA, were to assess current health behaviors, experiences, and satisfaction with the MOVE!TM Weight Management Program for Veterans via a mail survey of approximately 5,000 veterans who received treatment with MOVE! Managed the overall project, including proposal development, Office of Management and Budget clearance, survey development and administration contract oversight, and analysis of survey data.

Development of Clinician and Patient Resources in Support of U.S. Preventive Services Task Force Cardiovascular Recommendations (2009 to 2010)—Project Director. Through an interagency agreement with AHRQ, Dr. Kahwati led a project to develop clinician and patient brochures in support of U.S. Preventive Services Task Force cardiovascular recommendations. Four clinician fact sheets and five patient fact sheets were developed and tested with patients and clinicians at the VA. The final products were cobranded by AHRQ and the VA.

MOVE! Weight Management Program for Veterans: Best Practices Evaluation (2008 to 2011)—Co-Evaluator. This evaluation was designed to identify VA facility implementation policies, processes, and practices related to better weight loss outcomes among patients at selected VA facilities. Under contract to the VA, RTI led this evaluation, which used qualitative comparative analysis methodology. Drafted the statement of work for this project, which conceptualized the project, and served as an active co-evaluator throughout all phases of the project. In close collaboration with RTI staff, authored the published manuscript that was derived from the project's final report.

MOVE! Weight Management Program for Veterans: Clinical Program Evaluation (2006 to 2012)—Principal Evaluator. This evaluation was designed to provide an ongoing infrastructure to monitor the performance of the MOVE! Weight Management Program for Veterans. It used the Reach Effectiveness Adoption Implementation Maintenance framework and included an annual summative report in addition to monthly data summaries for key measures. Under contract to the VA, RTI led the effort to devise the methodology for determining weight loss outcomes using existing clinical data from the VA electronic health record used in the ongoing clinical program evaluation. Managed the overall portfolio related to evaluating the MOVE! Program, which involved close collaboration with VA MOVE! Program and policy staff, scientific oversight of VA analytic staff, collaboration with staff from across several VA business units, and technical monitoring and collaboration with contractors.

Long-Term Outcomes of Bariatric Surgery in the VHA (2006 to 2010)—Co-Investigator. The aims of this project were to determine and compare survival, health care use and expenditures, and patient-level predictors of survival and adverse events among morbidly obese veterans who had bariatric surgery in VA medical centers from 2000 to 2006 compared with a nonsurgical cohort of obese veterans. Served as part of the multidisciplinary research team; provided input, review, and feedback on clinical/medical aspects of the project; communicated findings to senior VA leaders; and evaluated how findings can/should impact VA policy and programs with respect to bariatric surgery.

CDC Coordinating Systematic Review Team for Obesity Prevention and Treatment Interventions (2006 to 2010)—Co-Investigator. Systematic reviews included worksite interventions, screen-time reduction interventions in children and adolescents, and technology-based interventions for obesity prevention and control. Reviewed and provided feedback on the definition of key questions, outcomes, and other elements captured as part of the review. MOVE*VETS-Dissemination of a Weight Management Program among U.S. Veterans (2005 to 2012) —Co-Investigator. The aims of this project, funded by the National Cancer Institute and awarded to UNC-CH, were to develop and test several enhancements to the MOVE! Weight Management Program for Veterans with a cluster randomized controlled trial at 10 VA medical centers. These enhancements included a tailored newsletter and the use of veteran peer counselors. Served as a co-investigator and senior VA project coordinator. Provided expertise at all stages of the study (proposal development, study execution, analysis) got MOVE! Program design and implementation within the VA. Managed recruitment of the VA sites for the study, provided support and technical assistance to VA sites for obtaining IRB approval, and assisted UNC study staff with setting up study processes and procedures to be compliant with all applicable VA policies and requirements.

MOVE! Weight Management Program for Veterans Technical Support and Assistance (2003 to 2008)—Medical Consultant. While at the VA, Dr. Kahwati was the medical consultant for all program resources developed in support of the VA's national weight management program (MOVE! Weight Management Program for Veterans). This included numerous program reference manuals, point-of-care decision aids, and reference items. She was also the lead content developer for VA-specific online training courses in weight management tailored to five different disciplines (physician, nursing, dietetics, psychology, physical activity specialists) that were also accredited for continuing education.
