RESEARCH STATEMENT

Since beginning my position at The University of North Carolina at Chapel Hill as an Assistant Professor, I have developed, implemented, and led an interdisciplinary program of research and have demonstrated success in obtaining intramural (e.g., UNC Institute for Environmental Health Solutions/UNC Center for Environmental Health and Susceptibility; 2020-2021; PI: Brooks; \$40,000) and extramural (e.g., 5 K23 ES027026; 2016–2021; PI: Brooks; \$686,440 direct costs) funding. Thus far, my research has focused on addressing racial and ethnic disparities in health outcomes, particularly among American Indians. My current research centers on understanding American Indian women's vulnerability to specific environmental air pollutants and whether psychosocial states, specifically positive emotions, might protect against cardiovascularassociated inflammation arising from particulate matter. I also served as a co-investigator on Drs. John Lowe and Julie Baldwin's NIH/National Institute on Drug Abuse (NIDA)/National Institute on Alcohol Abuse and Alcoholism (NIAAA) grant Intertribal Talking Circle (ITC) for the Prevention of Substance Abuse in Native Youth (5 R01 DA035143). I have demonstrated consistent leadership and excellence by disseminating research findings in high-impact nursing and interdisciplinary journals, including Research in Nursing & Health and Maternal and Child Health Journal, among others. Since 2013, I have published 14 manuscripts – five first-authored and nine co-authored – in peer-reviewed journals. Many of the publications relate to the environmental and biopsychosocial factors that contribute to racial disparities in health. Based on my interests and work in racial health disparities, I co-authored a book chapter, Race, Ethnicity, and Cultural Influences, in Chronic Illness Care: Principles and Practice, a foundational textbook that provides both conceptual grounding and applied, evidence-based approaches to chronic illness care for medical students, advance practice provider students, nursing students, residents, and other providers, such as allied health, public health, and mental health care providers. The book was published by Springer. I have also presented original research with my colleagues at national and regional research conferences. Thus, I am committed to disseminating my research to advance health equity in diverse populations.

TEACHING STATEMENT

My teaching role spans the classroom and clinical settings and includes research advisement. I strive to create a positive course experience by using various approaches in both course and clinical instruction to maximize student learning opportunities. Since my initial appointment, I have had a reduced teaching assignment due to protected time in the first year and grant funding in subsequent years. I recently taught the graduate-level course N968, Writing the Pre-/Post-Doctoral Training Plan for a Research-Intensive Career. I co-developed and co-taught the graduate-level course N960, Framing Research to Advance Health Equity: Theories, Methods, and Measures. I have cotaught N835 Population Health and Epidemiology in the master's program and N253 Individual Development Across the Lifespan in the bachelor's program. I have taught the clinical component of N472 Nursing Care of Infants, Children, and their Families. My roles as a clinical instructor and co-instructor included curriculum revision, preparation, and delivery of course lectures, and student learning evaluations in the classroom and clinical settings. Another essential part of my teaching mission is to mentor future generations of nurses and other health professionals to practice excellence in research and conduct studies to improve population health outcomes. I have mentored and guided the research of baccalaureate, master's, and predoctoral (PhD) students in the School of Nursing. This includes chairing one doctoral committee, two baccalaureate honors committees, and three master's student committees. I have served as a committee member on two master's committees and currently serve on two PhD committees.

SERVICE and ENGAGEMENT STATEMENT

I have been actively engaged in service at the School of Nursing, University, State, National, and International levels. I currently serve as the PhD Program Lead Faculty in the School of Nursing (SON). Other contributions to the SON include serving on the PhD Admissions Committee (PhDAC) and the Faculty Executive Committee as PhD Faculty Representative. I have served on the Workplace Violence Committee, Carrington Leave and Travel Committee, and the Pauline W. Brown Diversity Scholarship Committee in previous years. I have presented in the UNC SON Research Support Center (RSC) & T32 seminar series. I have served as a Success Champion, a role model and coach for undergraduate nursing students through a student-centered program, Meeting Educational Needs Through Optimization of Retention Strategies for Students, funded by Health Resources and Services Administration (HRSA) the SON (PI: S. Rogers) at UNC. University activities include serving on the UNC First Nations Council and Southern Oral History Program Medical Advisory Board. I have also served on the UNC Committee on the Status of Women and UNC American Indian Center Advisory Board. For example, I was appointed as a Faculty Fellow in the UNC Center for Environmental Health and Susceptibility and as an investigator at the UNC Center for Environmental Medicine, Asthma and Lung Biology.
