SUMMARY

I am a trained population health disparities research scientist, clinical psychologist, and program evaluation specialist with over a decade of experience. The focus of my published peer-reviewed articles and book chapters is the role played by psychosocial determinants (e.g., racism and masculinities) in health disparities/inequities (e.g., within Black adolescent and adult male populations). My methodological expertise lies in using quantitative/qualitative approaches to conduct cross-sectional and longitudinal studies, as well as, process, impact, and outcome evaluations. For the past three years, I have served as Director of the UConn Health Disparities Institute. As an appointee in the Obama Administration, I served as Special Advisor on military mental health (e.g., Trauma/PTSD, Military Sexual Trauma, Suicide) policies to Secretary Leon Panetta. Currently, I serve on boards for academic research journals, governmental committees, and community foundations at the local and national level. I also chair a number of local and federal policy initiatives aimed at improving the health and well-being of boys and men of color.
