

### **Checks and Balances**

 County general ledger for state expenditures should balance to the ATC requested amount each month.

 Program audits to ensure proper draw down of state funds

 Administrative monitoring to ensure proper method for calculating ATC

### Some Rules

 Entries must be certified by midnight in order to get funds.

 If entries are not completed by the deadline you must amend the report next month.

 Approximately 3 days after the deadline you will receive an electronic funds transfer.
