## THE FELLOWSHIP

This exciting research fellowship provides you with the opportunity to work with FHI 360's world-renowned researchers in global health. Entering its twentieth year, the fellowship has [trained 48 fellows](#) who have worked on over 100 projects. FHI 360 researchers are particularly interested in creating and testing multi-sectoral, integrated solutions to complex health problems facing the most vulnerable populations. FHI 360 provides technical assistance and leadership in implementing programs in HIV/AIDS treatment and prevention, TB and TB-HIV care and treatment, malaria prevention, NTD treatment and prevention, nutrition, WASH, and uptake of modern family planning methods.



Examples of specific areas of interest also include prevention of gender-based violence, use of mobile phones to deliver health promotion messages, and using GIS-based technology and analysis to impact policy for preventing maternal and neonatal deaths. As a fellow, you will have hands-on learning experiences that will expand your research skills as well as provide opportunities to make meaningful contributions to research and other project-related activities. It is estimated that you will work at FHI 360 20 hours weekly from approximately May 2024 to May 2025.

### Benefits

This one-year fellowship will provide you with in-state tuition support for the academic year at the UNC Gillings School of Global Public Health (fall and spring semesters), a stipend (summer, fall, and spring), university fees (fall and spring semesters) and health

insurance (fall and spring semesters). Please note the coverage of university fees does not cover special departmental/concentration fees. Your assigned project has the potential to provide you with the basis for your dissertation or master's thesis and may also fulfill practicum requirements. You will also have the resources and amenities of FHI 360's headquarters building, situated just next door to the Durham Bulls Stadium in downtown Durham, at your fingertips!

FHI 360 is located on the American Tobacco Campus at 359 Blackwell, Suite 200, Durham, NC 27701. As of October 2023, the FHI 360 office in Durham, NC is open. Staff, including fellows, are not mandated to work in the office, but would have the option to do so and would be allotted space and parking.

### Application Process and Eligibility

Eligible candidates are current (1st and 2nd year) or prospective doctoral students and rising second-year master's students who will be enrolled in UNC's Gillings School of Global Public Health throughout the fellowship. Please note: Rotary Peace Fellows and Fulbright Scholars are ineligible for this fellowship due to their funding. Applicants and selected fellows must be in good academic standing (see application for criteria).

All applicants should alert your program that you are applying for the FHI 360-UNC fellowship. You will need to request a tuition remission from your degree program if you do not receive in-state residency designation and are awarded the fellowship. If not awarded tuition remission, you will be responsible for the cost difference between in-state tuition (covered by the fellowship) and out-of-state tuition.
