Clinical Activities:

In my 22 years since completion of residency, my clinical career has been marked by three themes, 1) pediatrics 2) maternity care, and 3) care of vulnerable populations. In addition, I have always remained committed to care across the lifespan and inclusion of procedures in my scope of practice.

I decided as a resident that I wanted to assure that I maintained a robust pediatric practice. I devised two strategies early in my career—become a family practice expert in pediatrics and deliver babies (who would often become my patients). In my first three years at a practice in Siler City, my practice was nearly half pediatrics. I started to develop expertise as a clinician and academic in pediatrics with my second publication, a review article on Attention Deficit Hyperactivity Disorder, as a resident. Since then, I have published 18 additional book chapters, review articles, evidence summaries, and commentaries on pediatric topics. I have also given at least ten CME lectures or grand rounds as an invited speaker on pediatric topics. Importantly, I continue to maintain a robust pediatric practice, and I am consulted on difficult cases by residents and colleagues, and continue to be chosen as a family doctor for the children of many colleagues.

In addition to general pediatrics, I developed an interest in the evaluation of child abuse and neglect in medical school, received further training during residency, and developed a structured curriculum as part of my research fellowship to develop this expertise. Many of my pediatric publications focus on clinical aspects of child abuse and neglect. I served as a member of the Beacon Child Protection Team at UNC Hospitals from 2005 to 2019 as a consultant to pediatricians, pediatric surgical specialists, intensivists and family physicians. From 2009 to 2019 I served as the associate medical director of the North Carolina Child Medical Evaluation Program, coordinating a training series for providers that perform child abuse exams and serving as a remote medical consultant for child protective service workers and health care practitioners. In this clinical role, I served as an expert witness in court on numerous occasions.

Health Policy Activities:

As a student in Public Health over 25 years ago, I was easily convinced of the powerful role that policy can have in health. Policy can lead to funding, changes in health insurance, changes in health education or incentives to change behavior. I see health policy as one of the most important levers in improving health. As a researcher, I studied health policy issues around the role of poverty, education, and access to social resources as key drivers of abuse and neglect. I also studied the health policies necessary and the implications of universal education to prevention abusive head trauma.

From 2012-2020, I worked deeply in state health policy at the North Carolina Institute of Medicine (NCIOM) as the Vice President for about two years, then as President and CEO for six years. The NCIOM is a quasi-state agency chartered by the North Carolina General Assembly in 1983 to provide balanced, nonpartisan information on issues of relevance to the health of North Carolina's population. In this work, I engaged frequently with legislators, senior leadership in executive agencies and presented regularly to committees of the General Assembly. We achieved remarkable success, with partial or complete implementation of 50-90% of recommendations. Some of the highlights of our work involved dementia care, access to health care, integrated care, intensive home visiting, and quality of care. Under my leadership at the NCIOM, we developed our newest long-term program, a Legislative Health Policy Fellows Program for state lawmakers.

The NCIOM publishes the North Carolina Medical Journal and has done so for 21 years. Under my leadership, we moved to a mostly electronic dissemination, invested in a robust electronic platform, and dramatically expanded the footprint.

Lastly, my leadership in the NCIOM is worth noting directly. The organization thrived under my leadership. We went from a financial deficit for three years in a row before I started as interim president to a financial surplus for six years in a row that far exceeded that deficit. We did this mostly through a combination of careful waste cutting (updating business practices to be more fiscally responsibly) and renewed efforts at fundraising with new partnerships. We also successfully transitioned from a self-perpetuating board to a board that has been appointed by the Governor and the legislature. We developed an organizational climate of which I was proud. We fostered inclusiveness, hard work, and collaboration.

Research Statement

Over the past 22 years I have work in clinical and health services research, mostly in child maltreatment prevention. I started my work mostly by publishing analyses from a locally available survey of parenting behaviors. I worked on scale development, social capital, co-occurring violence, and corporal punishment. I worked on the development of a new set of international survey tools to study violence against children in a broad context and presented many times at international conferences. I also worked as the principal investigator of a large evaluation study of a statewide implementation of an abusive head trauma prevention program. We applied novel econometric models to child

maltreatment research for the first time, a method which has since been replicated, thereby helping to develop the methods for this field. I have also worked on three AHRQ funded systematic reviews to look at violence and trauma, one JAMA published Rational Clinical Exam (sexual abuse findings), and a systemic review of national bans on corporal punishment. I am best known in my field for my 1) my work in survey tool development and large-scale survey research, 2) my working in corporal punishment research, and 3) my use of econometric analytic technique to advance the analytic rigor of the field. Web of science shows that 14 of my publications have been cited more than 25 times and six have been cited more than 50 times. Research expertise has led to invitations to serve on three editorial boards, two national advisory committees (including one national survey tool and one child abuse prevention program) and invitations to author many book chapters.

As I transitioned to devoting more time to state health policy work (combining my clinical and research skills to address real world health policy challenges), my typical academic research portfolio has become more limited. I maintain a small portfolio of research work and have devoted more time to mentoring junior colleagues and students.

Teaching Statement

Teaching activities throughout my career have included regular lectures to medical students and residents during noon conference on topics relevant to children's health or women's health/perinatal care. I guest lecture regularly in the school of public health. From 2007-2010 I taught the scholarship curriculum to our part-time family medicine faculty development fellowship.

My clinical supervisory experience has been as a regular attending on our department's maternal/infant service, outpatient precepting of residents, and supervision of medical students in clinic, emergency room, and health department settings. As a family physician that practices maternity care I have had the privilege of working with 21 classes of family medicine residents over the past 19 years. I have also taught maternity care to countless acting interns. I have a passion for helping residents to connect with families during this poignant transition in life. As a former service director and one of the more senior physicians on our maternity service, I am occasionally asked to review a critical incident or support a resident or colleague after an emotionally difficult case.

In my academic work, I have served as a mentor to several current and future research faculty. I currently serve as a mentor to two assistant professors one on an institutional K award (KL2). I have served as a supervisor one post-doctoral research fellow and a mentor to two other fellows. In my work at the NCIOM, I mentored to 1-2 graduate students per year, teaching them about the challenges of state health policy.

Lastly, I serve as a teacher when I disseminate my research work or share what I have learned about state health policy. In my more traditional academic research role, I have worked on 50 presentations at national and international meetings. As I worked more on state health policy over the last eight years, my audiences changed and the need to teach

to the audience has become even more profound. I have presented at least 76 times to state health policy audiences in the last five years. Audiences range from committees of the North Carolina General Assembly to the Alzheimer's chapter annual meeting.

Diversity, Equity, and Inclusion Statement

In the year 2020, the US has had a reckoning with the historical legacy of race and racism which has impacted each of us in profound personal and professional ways, hopefully for the better. Even as some of the day-to-day attention to police reform, white supremacy, and reparations unfortunately fade, we continue to see the profound impact of racist policies in education, health care, and the economy. I have chosen to continue my own self-examination of past and current words and actions and my journey in self-education as reflected in my DEI activities section. This represents not new work, but perhaps a new chapter and a deeper understanding. I have spent my career focused on vulnerable populations, the prevention of child abuse, and access to care using clinical medicine, research, and public policy as tools to address systemic disadvantage. I am now more explicit about the role of race in these issues in my work and more intentionally inclusive of racially diverse voices in all my work.

Reflective Statement

In my career, I feel compelled to serve people and my community through my clinical practice of family medicine and people more broadly through research and policy

analysis. The small ways in which we touch the lives of people every day makes the practice of medicine a joy. I strive to practice the highest quality medicine in an efficient and cost-effective manner. The notion of providing care from cradle to grave inspired me to a career as a family physician. These great passages of life, birth and death, continue to be the most important time for me to be a physician with families and patients.

As a researcher, I chose to focus on the areas of child maltreatment and early childhood injury. I am drawn to this area because of the complexity and the opportunities to improve the lives of young families and children. The relationship between parents and parenting is overwhelmingly dominated by parent mental health, creating a groundswell opportunity for a family physician researcher. I have come to think of child maltreatment as one of the many health outcomes of our socio-ecologic context that sets the conditions of our environment and behaviors. This context has a far greater influence on health than the direct care I provide to my patients. As I transitioned away from the NCIOM back to full time academics, I began to think of my research more broadly. I continue to work on child maltreatment prevention, but now consider factors such as poverty, rurality, social deprivation, and housing as important determinant of health as well as the best ways to address these challenges from a health system and health care perspective.

Policy holds one of the great keys to improved health. Policies may reflect funding priorities with resources of local, state, and federal government available to invest in health. Policies may also take the form of legal mandates such as required use of car restraints. At its most effective, public policy can take the resources and needs of stakeholders to develop and implement a vision around the complex health needs of people. Over the last six years, I have had the privilege to work with stakeholders across North Carolina, disseminate evidence, develop consensus, and make recommendations to policymakers at all levels.
