GODDESS (Gathering Online for Dialogue and Discussion to Enhance Social Support): Engaging Young African American Women in a Virtual Group App to Address Alcohol Misuse, Sexual Risk, and PrEP in NC (2022 to date)—Co-Investigator (Co-I). This implementation science study is funded by the National Institute of Mental Health (R34MH124628) and is adapting a stigma-reduction training to reduce clinic-level stigma; developing a prescribing platform to help providers' clinical decision-making regarding pharmacotherapy for mental health disorders and/or alcohol use disorders and testing the platform's feasibility in Ryan White-funded care sites in the Atlanta area.

Couples Health CoOp (CHC+) (2020- date) — Co-I. This National Institute on Drug Abuse (NIDA; R01DA049612; MPIs: Wechsberg, Browne, Carney)-funded project addresses substance use, other risk behaviors, ART, and PrEP, and the impact of stigma reduction workshops in the community in Cape Town, South Africa.

Implementation Science Study to Evaluate Strategies to Support HIV Prevention among Women (2021 to date)—Principal Investigator (PI). This study examines implementation strategies of injectable PrEP for HIV prevention among women in high HIV prevalence areas in the United States.

The EMPOW-HER Project: Educating Medical Providers on Women-Controlled HIV Prevention to Expand Reach to African American Women in Atlanta (2020 to date)—Project Director (PD). This implementation science pilot study is funded by the National Institute of Allergy and Infectious Diseases through the University of North Carolina at Chapel Hill (P30AI050410; PI: Swanstrom) and is adapting

and evaluating an online training to preexposure prophylaxis for HIV prevention (PrEP) training to increase on PrEP knowledge and provision of PrEP among sexual and reproductive healthcare providers who serve Black women.

The PREPaRE Pretoria Project: PRevention, Empowering, and PRotEcting Young Women in South Africa (2017 to date)—Co-I. This implementation study, funded by the Eunice Kennedy Shriver National Institute of Child Health and Human Development (R01HD094629; PI: Wechsberg), aims to increase uptake and adherence of preexposure prophylaxis (PrEP) for HIV prevention among vulnerable HIV-negative adolescent girls and young women aged 16 to 24 who engage in high-risk sex, by using a multilevel HIV prevention strategy that addresses stigma and discrimination, social support, and individual risk behaviors across 12 healthcare centers.

Young Women-Focused HIV Prevention: Seek & Test in North Carolina Clinics (2016 to date)—
Research Associate. The goal of this NIDA-funded (R01 DA041009; MPI: Wechsberg, Browne) study is to develop and test the efficacy of an age-appropriate, woman-focused HIV intervention initiated in HIV testing clinics that will provide risk reduction, empowerment skills, and linkage to substance abuse treatment.

This pilot study is funded by the Fordham HIV and Drug Abuse Prevention Research Ethics Training Institute, through NIDA (R25DA031608; PI: Fisher), and examines the experiences of young women who participate in HIV prevention research to improve the development of ethical research practices among vulnerable young women in Cape Town, South Africa.

Expanding HIV Testing and Prevention to Reach Vulnerable Young Women (Young Women's Health CoOp) (2018 to 2020)—Diversity Supplement Scholar. The goal of this NIDA-funded (R01DA041227; PI: Wechsberg) supplemental study was to assess comorbid mental health symptomology and substance abuse among young women in the study and understand the feasibility of integrating mental health, substance abuse treatment, and HIV treatment and prevention services for young women in South Africa.

Implementation Research of the Women's Health CoOp in South Africa (2016 to 2020)—Research Associate. This 5-year NIAAA—funded R01 project (R01AA022882; PI: Wechsberg) developed and tested an implementation strategy for integrating a woman-focused evidence-based intervention to reduce substance use and HIV transmission risk and increase adherence to antiretroviral therapy into eight public health clinics and substance use treatment centers in Cape Town, South Africa. Assisted with qualitative data collection, led data collection and analyses to assess the cost of implementing the intervention into usual health care settings in South Africa, and co-authored manuscripts and presentations.

Combination Prevention for Vulnerable Women in South Africa (Women's Health CoOp Plus) (2016 to 2019)—Research Associate. This 5-year study (R01DA032061; PI: Wechsberg) compared the effectiveness of the standard test, treat, and retain model (TTR) versus an enhanced, woman-focused model that integrates the TTR with the Women's Health CoOp PLUS intervention among vulnerable women at high risk for HIV in Tshwane, South Africa. Led data analyses and significantly contributed to manuscript preparation.

Improving Brief Alcohol Interventions with a Behavioral Economic Supplement (2012 to 2013)— Clinical Interviewer/Research Assistant. The purpose of this randomized controlled trial, which was funded by NIAAA (R21AA016304), was to improve and evaluate the efficacy of the brief intervention on the basis of motivational interviewing and behavioral economic theory to reduce drinking among heavy-drinking college students.
